REQUEST FOR PROPOSALS

TO CONDUCT CAPACITY BUILDING FOR THE JW 25 COMMUNITY LIAISON OFFICERS ACROSS THE CITY OF JOHANNESBURG

Project Duration: 5 Days

1. BACKGROUND

Johannesburg Water (JW), as an entity of the City of Johannesburg (CoJ) has been mandated to distribute clean water to the residents within the CoJ as well as the responsibility to collect and treatment of sewerage. The upgrading of the infrastructure is done through the CAPEX department wherein each financial year the budget is shared throughout the CoJ Regions by means of allocating financial resources for different projects focusing mainly on infrastructure upgrading. The Stakeholder Relations Department within JW is therefore tasked with the responsibility of ensuring that there is community buy-in for sustainability of all the projects implemented. This includes dealing with all the socio –political issues that are raised at the duration of the project. The department also appoint the Community Liaison Officers (CLO`s) who serve as a link between JW, the community and the Councillor. The CLO`s are sourced from their locality; in wards where projects are being rolled out, since the understanding is that they know the dynamics of the areas where projects are implemented.

2. OBJECTIVE

To ensure that the CLO`s are capacitated and that there is maximum participation of the CLO`s in their involvement for as well as the efficient CAPEX projects support, an extensive capacity building workshop needs to be provided

by a seta accredited service provider on the following identified courses over a period of five days:

- Public speaking skills;
- Conflict resolution skills;
- Report writing skills;
- Labour Relations.

Over and above the above mentioned modules, the successful service provider will be required to summarize on the following content with the attendees and be included in the training manual:

- How local government operates;
- Key water and sanitation policies;
- Role of CLO`s in project implementation;
- Dealing with socio-political issues;
- Public participation processes

The above –mentioned areas of competency will assist the CLO`s in executing their duties effectively.

3. EXPECTED OUTCOME

- The successful service provider will be expected to ensure a successful capacity building for the Community Liaison Officers and issuing of certificates after completion ;
- To have competent and fully capacitated CLO`s who clearly understands the key focus areas of the training ;
- To ensure simplicity of the technical concepts to the target audience so that they clearly understand their roles and responsibilities; and how they fit into ensuring the effective service delivery within the roll out of the projects.

4. INVITATION TO SUBMIT RFP`S

JW invites suitably qualified and experienced interested Parties and Stakeholders to conduct an extensive capacity building workshop / training of the 25 Community Liaison Officers across the COJ.

The capacity building programme will include amongst others:

- Capacity building of the 25 Community Liaison Officers;
- Capacity building to the identified CLO`s on the issues mentioned on number 2 above through class-room training;
- The capacitated CLO`s would be expected to role play on the activities learned towards the end of the training to ascertain knowledge acquired during the training period;
- Awarding of accredited certificates of competency to the attendees & certificate of attendance after completion of the training;
- Presenting the final report to JW once the work has been completed highlighting challenges, achievements and recommendations;
- Develop a brief but comprehensive accredited training manual which will be distributed amongst the identified CLO`s which is compulsory to be submitted back to JW with the quotes, failure to submit which leads to disqualification.
- Issuing of writing pads and pens to the 25 attendees.

Interested parties are requested to submit their proposals indicating how the training will be conducted for all the identified CLO`s and ensuring that the target audience clearly understood the concepts they were capacitated on.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.

7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) Methods, factors or formulas used to calculate prices;
 - (d) The intention or decision to submit or not to submit, a bid;
 - (e) The submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) Bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
