Johannesburg Water Reservoirs remain severely strained: Residents advised to use water sparingly

Whilst there has been improvement in levels at both Rand Water's Waterval and Meredale Reservoirs, Johannesburg Water's infrastructure remains critically constrained.

The following systems remain critically low:

Commando system (Crosby, Brixton and Hursthill Reservoirs)
Eagle Nest reservoir

Johannesburg Water urges customers to continue using water sparingly and only for essential purposes. Customers in higher lying areas may experience low pressure/ no water during this period.
