### Smart lock loaded mechanism:

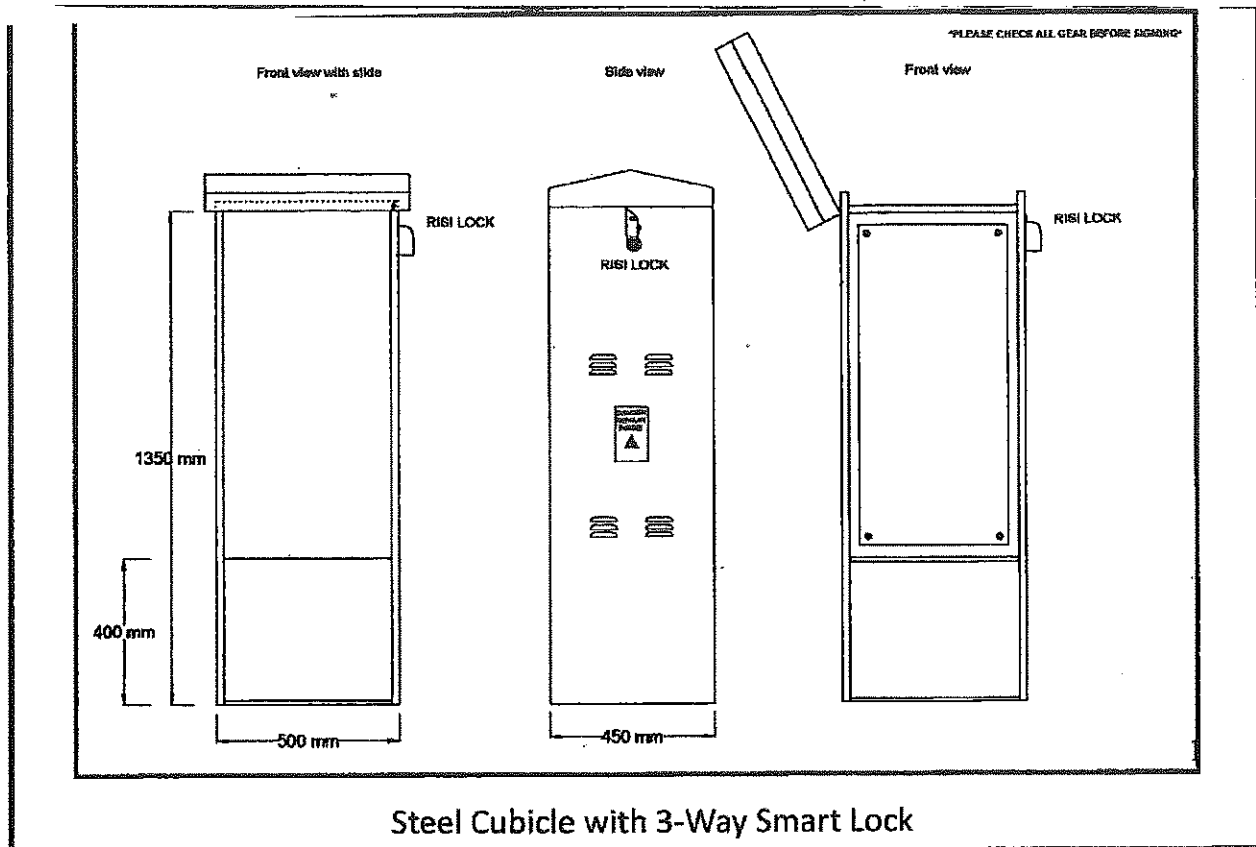
The loaded mechanism is attached to the Smartlock and is designed to automatically clip into the roof mountings. The spring loaded system on the mechanism is used in case the lock is damaged and will instantaneously lock the unit under protection. The lock is further protected by a cast cover. The curved outer shell of the cover makes it impossible to be cut through ensuring that the only thing getting close to the inner lock is the key.

### Cubicle:

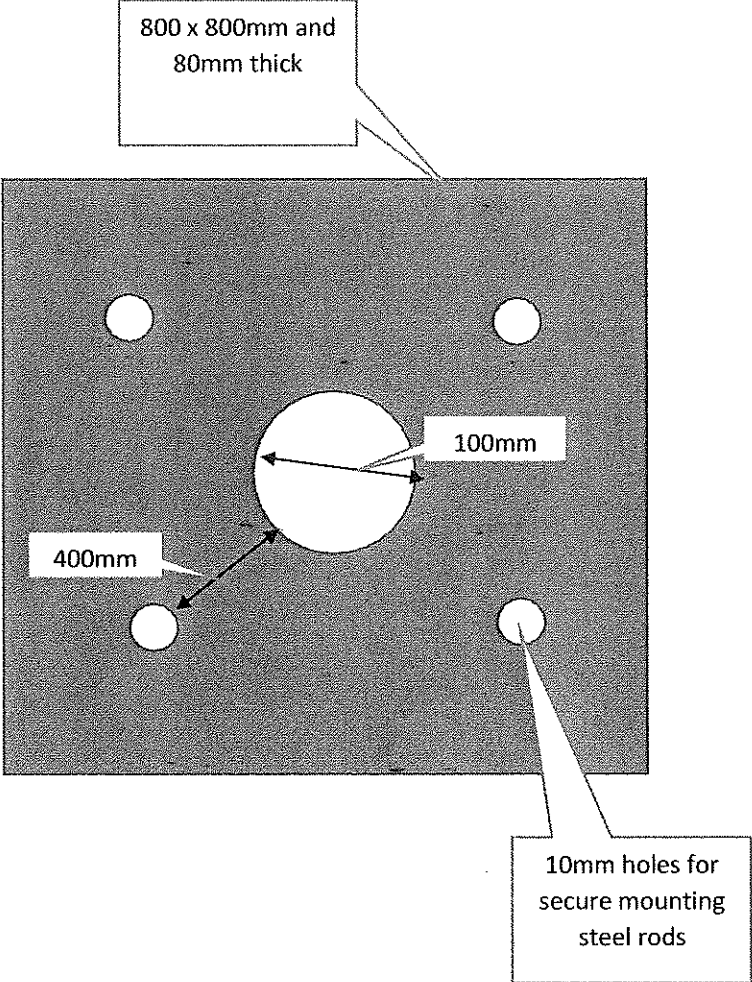
The cubicle is specially designed with hidden doors and sliding panels to prevent any tampering from the outside. There are no visible doors or locks that can be damaged.

The cubicle is insulated with polystyrene and special air vents are included to reduce the buildup of heat to keep the instruments cool.

## CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids<sup>1</sup> invited.
