Systems Update: Johannesburg Water's systems are gradually recovering

Johannesburg Water has noted some improvements in most systems. The bulk supplier is pumping an additional 100ML which is contributing to improvements in the Roodepoort system. Complete recovery will take a few days. The Entity is constantly monitoring the progress.

Systems that have not recovered

The following systems are still struggling to improve and are critically low to empty. Poor pressure to no water is expected in the supply zones.

The bulk supplier's systems are interconnected and are flexible to augment (support) one another, which assist in the recovery of all systems. Johannesburg Water will prioritise the prompt isolation of bursts and leaks and the repair thereof. Customers are requested to repair leaks on their properties as these also contribute to the high demand on Johannesburg Water systems. Residents are requested to observe level-1 water restrictions which are implemented from 1 September to 31 March. These restrictions prohibit the use of hosepipes to water gardens, wash cars, clean driveways, as well as fill up swimming pools and water features between 06:00 and 18:00. Instead, the use of greywater is encouraged.
