



Daily water supply system status updates: Friday, 14 July 2023 (Morning)

Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

Unplanned interruptions

1. Area affected: Linbro Park

Street names: 3rd Avenue, Hilton Road, 1st Road, 2nd Road, Clulee Road, Oak Avenue and Reid Avenue

Date: 18 July 2023

Time: 07:00 – 19:00

Impact on customers: No water

Reason for interruption: Connection of newly constructed 300mm to a 200mm mainline

Planned interruptions

1. Rand Water planned shutdown: repairs complete

The repairs that were conducted during the planned Rand Water shutdown, from Tuesday, 11 July at 19:00, to Friday morning at 05:00, have been completed and Johannesburg Water systems are gradually recovering.

Although work has been completed, Johannesburg Water customers are reminded that full recovery will take five to 14 days. Customers in higher-lying areas will experience the outage for a longer period as the network gradually recovers. The Commando system (Hursthill, Brixton, and Crosby), a historically problematic system, will take longer to improve.

Johannesburg Water will continue providing alternative water supply to areas that are still struggling, particularly in the Johannesburg CBD as well as hospitals and clinics.

Customers are urged to use water sparingly, only for drinking and cooking, and hygiene purposes. Please refrain from watering your gardens, filling up swimming pools, and using hose pipes to wash cars.
