Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

Unplanned interruption

1. Bryanston: burst pipe at corner Bruton Road and William Nicol Drive

Johannesburg Water technical teams are attending to a burst pipe at corner Bruton Road and William Nicol Drive. As a result, parts of Bryanston are without water. Materials for repairs are being sourced. Further updates will be provided to customers.
