Daily water supply system status updates: Friday, 28 April 2023 (Morning)

Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

Unplanned interruptions

1. Major burst in Oosterland Avenue, Bloubostrand

The team isolated water at midnight to ensure the draining of the 600mm bulk main. Excavation and repairs will commence today, 28 April, once the network has sufficiently drained. **Affected areas include parts of:**

Johannesburg North, Cedar Lakes, Cedar Creek, Broadacres, Needwood, Kya Sands, Northriding, Bloubostrand, Chartwell, Msawawa Informal Settlement, Tirong and Farmall.

The estimated completion is 28 April at 22:00. Further updates will be provided to customers. Johannesburg Water apologises for the inconvenience caused.

2. Cancelled Rand Water repairs affecting Hursthill 1 and 2 reservoir zones

Please note that Rand Water was scheduled to do repairs on Thursday, 27 April at Johannesburg Water's Hursthill 1 and 2 reservoirs as part of their malfunctioning meters replacement programme. However due to technical challenges on the system, it was cancelled. This has affected water supply to the Hursthill 1 and 2 reservoirs, and some areas are experiencing low pressure to no water. Although water supply has been restored, it does take time for the system to full recover and for water supply to be back to normal.

Suburbs affected include parts of: Hursthill, Albertville, Franklin Roosevelt Park, Westbury, Northcliff, Albertskroon, Greymont, Coronationville, Claremont, Newlands, Martindale, Triomf, Montclare, Westdene, Newclare, Delarey, Montgomery Park, Parkview, Melville, Greenside, Richmond, Parktown, Westcliff, Emmarentia, Auckland Park, Rossmore, Victory Park Estate S.H., and Parkhurst.

3. Investigation into intermittent supply in high lying areas of Sundowner and Northgate

Johannesburg Water is aware of complaints of intermittent supply in parts of Sundowner, Northgate, Northwold and surrounding areas. Rand Water and Johannesburg Water teams are working together to find the cause of the problem. Investigations are underway at Honeydew reservoir as well as inspecting PRVs in the affected areas. Alternative water supply will be provided in the following streets:
