Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

### **Planned interruptions**

**1. Areas affected:** Kew, The Gardens, Rembrandt Park, River Park, Glenhazel, Sandringham, Silver Mond, Lombardy East and West, Bramley, Bramley View, Wynberg, Athol Hurst and Alexandra.

**Impact:** No water

**Reason:** Bulk line valve installation

**2. Areas affected:** Naledi Ext.2 and Protea North

**Date:** 9 March 2023

**Time:** 07:00 - 16:00

**Impact:** No water

**Reason:** Chamber Fittings Configurations Retrofitting

Residents are again requested to observe Level-1 water restrictions implemented from 1 September to 31 March, which prohibit the use of hosepipes to water gardens, wash cars, clean driveways but use grey water instead, fill up swimming pools and water features between 6 am and 6 pm. This is to ensure that systems are kept stable throughout the coming months. We urge residents to report any form of vandalism and theft of water infrastructure to 0800 00 25 87.
