Daily water supply system status updates: Monday, 09 January 2023 (Afternoon)

Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

Unplanned Interruptions

1. Major burst on trunk main at corner Tanaroad and Nanyuki road, Sunninghill Johannesburg Water wishes to inform residents of the emergency shutdown taking place on 11 January 2023. Repairs need to be completed on a trunk main at corner Tana Road and Nanyuki Road. Water will be isolated from 05:00 on 11 January 2023. Affected areas include parts of:

Sunninghill, Gallo Manor, Rivonia, Woodmead, Morningside, Edenburg and Waterfall. The estimated completion time is 20:00, same day. Further updates will be provided to customers.

2. Vandalised PRV's & Major Burst at Jim Fouche Road

Vandalised PRV's: Eight PRV's have been repaired and water has been restored in various areas including Weltevreden park, Strubensvalley, Allensnek and Amarosa.

The major burst at Jim Fouche Road is currently being attended to and Affected areas include parts of Strubensridge and Constantia.

Johannesburg Water thanks customers for their patience and understanding.

Residents are again requested to observe level-1 water restrictions implemented from 1 September to 31 March, which prohibits the use of hosepipes to water gardens, wash cars, clean driveways but use grey water instead, fill up swimming pools and water features between 6 am and 6 pm. This is to ensure that systems are kept stable throughout the coming months. We urge residents to report any form of vandalism and theft of water infrastructure to 0800 00 25 87.
