# **Unplanned Interruptions**

### 1. Replacement of AC main

Johannesburg Water wishes to inform customers of the emergency shutdown taking place to replace asbestos cement pipeline at corner Uranium and Cedar Road, Witkoppen.

#### Affected areas include:

Witkoppen, Maroeladal, Craigavon, and Fourways Life Hospital. Estimated Time of Completion is 5:00pm and, further updates will be provided to customers.

**UPDATE:** Johannesburg Water wishes to inform customers that work has been completed at corner Uranium and Cedar Road, Witkoppen. The team is currently restoring water in affected areas.

# 2. Recovery of Johannesburg Water Infrastructure

Johannesburg Water is monitoring severely constrained reservoirs and towers, impacted by the recent power failure at Eikenhof pump station.

Customers can assist by using water for critical needs only at this time. sustainability of capacity is dependent on water usage during the course of the day.

Reservoir level is critically low. The tower is stable.
