Daily water supply system status updates: Thursday, 1 June 2023 (Afternoon)

Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

Unplanned interruptions

1. Hursthill reservoir 2 shutdown: No water in parts of reservoir zone

Johannesburg Water customers in Auckland Park, Melville and Parktown West are affected by the shutdown, which has caused a water outage. The cleaning of Hursthill reservoir 2 is underway and will be completed by 6 June 2023. The reservoir will be commissioned on 7 June 2023. At this stage the reservoir is on bypass. Customers in high-lying areas are impacted by low pressure or no water. Arrangements are being made for alternative water supply to affected areas. Further updates will be provided to customers. Johannesburg Water apologises for the inconvenience caused.

2. Major burst: Leslie and Westway, Douglasdale

Water was isolated this morning and repairs on the major burst at corner Leslie Avenue and Westway Road, Douglasdale, will be finalised. Parts of the following areas are affected by the shutdown: Douglasdale, Norscot, Maroeladal, Craigavon, Witkoppen, Fourways Life Hospital, Witkoppen Clinic, Kengies, Beverley, Pineslopes, Lonehill, Fourways Gardens, Paulshof, Dainfern, and Magaliesig View.

Alternative water supply will be arranged for critical customers:

1. Fourways Life Hospital
2. Witkoppen Clinic
3. Cedar Tree Clinic
