Unplanned interruptions

Major burst pipe in Lanseria

There is a major burst pipe at corner N14 Road and Malibongwe Drive in Lanseria. Water has been isolated to allow the team to complete repairs on the damaged main, which is located in the veld. The team is onsite and is currently exposing the pipeline.
