Daily water supply system status updates: Thursday, 11 May 2023 (Morning)

Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

Unplanned interruption

Eskom power supply issue impacting Grand Central reservoir and tower

Residents in Grand Central, Midrand are currently experiencing a water outage that occurred on Wednesday afternoon. The unplanned water interruption was caused by an electrical fault on the supply to the Grand Central Pump Station. The electrical fault has been escalated to Eskom for urgent attention.

The water level at Grand Central Reservoir is critically low, which is resulting in no pumping to the tower. Customers in the reservoir and tower zone are affected by no water supply. As soon as the fault is repaired, Johannesburg Water will be able to pump from the Grand Central Reservoir to the tower. Roaming water tankers will continue to be deployed to affected areas. Further updates will be provided.
