Daily water supply system status updates: Thursday, 24 August 2023 (Afternoon)

Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

Unplanned interruption

1. Orlando East reservoir update

The emergency shutdown repairs that were being conducted on a burst 700mm steel water pipe, which feeds the Orlando East reservoir, on Wednesday 23 August were not completed due to technical challenges. The shutdown affected Diepkloof Zone 6, Soweto. As a result, there is no water inflow into the Orlando East reservoir. This will affect the whole of Orlando East and parts of Orlando West. Roaming water tankers have been deployed in Orlando West and Orlando East. Further details will be provided.

2. Suburbs affected: Dobsonville Extension 3, parts of old Dobsonville, and Zondi next to the Zondi reservoir

Street names: All streets

Start date and time: 24 August 2023

End date and time: 07:00 – 17:00

Reason for interruption: Repairing a leak on the inlet pipe to Zondi Tower

Impact on customers: Low pressure to no water

Alternative water supply: Water tankers will be provided should the planned work exceed the stipulated time

3. Suburbs affected: Kensington, Bruma, Malvern, and neighbouring suburbs

Street names: All streets

Start date and time: 22 August 2023 at 07:00

End date and time: 25 August 2023 at 18:00

Reason for interruption: Maintenance of Alexander Park reservoir

Impact on customers: During the maintenance of the reservoir, customers will have water. However, in the event that the cleaning does not go as planned, customers might experience low pressure to no water.

Alternative water supply: In the case of a prolonged water outage, arrangements will be made for alternative water supply.
