Daily water supply system status updates: Thursday, 29 June 2023 (Morning)

Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

Unplanned interruptions

1. Zondi reservoir shutdown

The technical team finished repairs at around 01:00 this morning (Thursday, 29 June). Water was then opened, and the system is still building up. Four roaming water tankers have already been dispatched in the following areas, which are critical and are still under recovery: Zondi and Dobsonville. Further updates will be provided to customers.

2. Johannesburg Water attending to multiple pipe bursts in Orlando West, Soweto

Johannesburg Water is aware of the water supply challenges that have been affecting customers recently in Orlando West, Soweto.

There have been multiple bursts that have been occurring in the area for the past few weeks which have led to no water supply.

The Johannesburg Water technical team has been trying to resolve the issue by reducing the water pressure in the pipes (high pressure is one of the primary causes of bursts). Unfortunately, reducing the pressure in the pipes causes high-lying areas to be without water.

The team is currently on site to attend to the bursts. Residents in the following streets are affected: Bacela, Baqwa, Vilakazi, and Xorile.

Two stationary tanks have been organised to be placed at the corner of Xorile and Bacela streets, and the corner of Xorile and Baqwa streets. The team continues to work tirelessly to resolve the challenges.

Planned interruptions

1. Rand Water planned maintenance at Daleside pump station to impact Ennerdale meter

There will be a planned Rand Water shutdown on Friday, 30 June 2023 from 09:00 to 17:00. The bulk water supplier will be conducting maintenance at Daleside pump station. It is estimated that optimal recovery of the systems may take approximately five days.
