### **Daily water supply system status updates: Thursday, 6 April 2023 (Afternoon)**

Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

#### **Unplanned interruptions**

##### **1. Major bursts (Sunninghill, Bryanston, Peterville and Wendywood)**

Johannesburg Water apologises to customers in the following areas who are impacted by major pipe bursts: Sunninghill, Bryanston, Peterville and Wendywood.

Water has been isolated in various suburbs and relevant materials are being sourced for repairs to be completed.

##### **Major bursts in the following areas:**

1. Airdlin Road, Sunninghill
2. Hobart Road and William Nicol Drive, Bryanston
3. Frans Hals Street, Peterville
4. Daffodil Street, Wendywood

There is no estimated time for completion at this stage. Alternate water supply has been arranged for affected areas through mobile tankers.

##### **2. Emergency shutdown: Koma Road, Jabulani**

Please note that there is a major burst pipe at Koma road, Jabulani. The team is isolating water in order to repair the burst.

Estimated completion time is 18:00.

Affected areas: Jabulani (Hospital, Mall, Police station, fire station, flats) and Moletsane.
