Daily water supply system status updates: Tuesday, 16 May 2023 (Afternoon)

Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

Unplanned interruptions

1. Area(s) affected: Zondi reservoir & Dobsonville tower

Street name(s): All streets

Start date: 18 May 2023 at 20:00

End date: 19 May 2023 at 07:00

Impact on customers: No water

Reason for interruption: Repairing a water leak on a 400 mm diameter AC pipeline.

2. POSTPONED: City Power's planned maintenance postponed to 25 May 2023

The City Power planned maintenance power interruption at its Hursthill Substation, which will affect Johannesburg Water's Brixton and Northcliff systems, has been postponed to 25 May 2023. The planned maintenance, which was scheduled to take place on Wednesday, 17 May 2023 from 09:00 to 17:00, will impact the water utility's Brixton tower and reservoir, as well as the Northcliff tower. This will impact Johannesburg Water's systems, including the Brixton tower and reservoir, as well as the Northcliff tower. According to City Power, the power interruption is necessary for the utility to complete essential maintenance work on its network. Customers in these supply areas may be affected by poor pressure to no water during the outage. Further updates will be provided to customers.
