### **Daily water supply system status updates: Tuesday, 25 April 2023 (Afternoon)**

Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

#### **Unplanned interruptions**

##### **1. Valve installation Lion Park Informal Settlement**

Water has been isolated to allow for the team to install 2 valves at Lion Park informal settlement.

Affected areas include parts of:

Lion Pride Estate, Thabo Mbeki Informal Settlement, Lion Park Informal Settlement and Malatjie Informal Settlement.

Estimated completion time is 16:00.

##### **2. Major burst corner Bond Street and Elgin Avenue, Ferndale**

Repairs were completed late last night, and the teams have opened valves as well as the outlet of Kensington B reservoir. Customers in high-lying areas may experience low pressure to no water as the system recovers.

Affected areas include parts of:

Bryanbrink, Ferndale, Strijdom Park, Bryanston Ext 3, Osummit, Malanshof, Beverly Gardens, Ruiterhof and Meadowhurst.
