Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

Unplanned interruptions

1. Emergency shutdown: Eikenhof pump station

Please note that there is a flooding issue at Rand Water's Zuikerbosch Treatment Plant that will affect Eikenhof pump station.

The engine room that flooded supplies Mapleton and Eikenhof booster stations.

This affects the Commando system (comprising Brixton, Crosby and Hursthill).

Some of the motors were submerged in water. The return to service is not known at this stage.
