Daily water supply system status updates: Wednesday, 14 June 2023 (Afternoon)

Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

Unplanned interruptions

1. Monitoring of South Hills tower

Investigations are underway to establish the cause of reduced water supply at the South Hills tower. Further updates will be provided to customers.

2. Johannesburg Water systems showing improvement

As Rand Water systems recover, specific Johannesburg Water infrastructure have noted improved flows, impacting positively on capacity. The entity continues to closely monitor systems.

Below are the updates on reservoir and tower levels:

- Alexander Park reservoir: operating normally.
- Yeoville reservoir complex: reservoirs that were impacted yesterday are gaining capacity. The reservoir complex is operating normally.
- Crown Gardens: reservoir level is low but stable. Tower is operating normally. We have opened the outlet at 70%.
- South Hills tower: recovered. Pumps are running.
- Brixton reservoir and tower: reservoir outlet opened at 100%. Tower is operating normally. Monitoring reservoir levels.
- Hursthill 1 and 2: critically low to empty.
- 3. Major pipe burst on Fiona Street, Ridgeway, isolation of Crown Gardens reservoir Repairs on the pipe burst have been completed. The team is monitoring the work sites. A minor leak was noted on a valve in Fiona Street. The technical team will assess the severity of the issue.

Johannesburg Water customers to be affected by Rand Water planned shutdown Johannesburg Water customers will be impacted by a planned Rand Water shutdown to take place from Tuesday, 20 June 2023 from 19:00 to Thursday, 22 June 2023 at 15:00. The purpose of the planned shutdown is to complete a tie-in between the A19 and B14 with a new pipeline, installation of isolation valves, and systems upgrades at Rand Water's Eikenhof pump station.

Meredale 1 and 2

During the Rand Water shutdown, Johannesburg Water infrastructure supplied by the pump station will be affected by no water supply. It is estimated that full recovery of the systems may take approximately five days or longer after supply has been fully restored. Johannesburg Water will make arrangements for alternative water supply at strategic areas like hospitals, clinics, schools, municipal offices, police stations and shopping centres. Residents will receive regular updates on the official Johannesburg Water social media platforms.

5. Rand Water planned maintenance at Daleside pump station to impact Ennerdale meter

There will be a planned Rand Water shutdown on Friday, 30 June 2023 from 09:00 to 17:00. The bulk water supplier will be conducting maintenance at Daleside pump station. It is estimated that optimal recovery of the systems may take approximately five days.

Ennerdale South, Ennerdale Exts, Finetown, Grasmere, Mid-Ennerdale, Lawley Exts and Lawley Estate.

Customers in the affected areas may experience low pressure to no water during the period. Alternative water supply will be arranged for critical customers such as clinics and hospitals. Further updates will be provided.
